

## **SUMMARY ANNUAL REPORT FOR VERSITI 403(B) RETIREMENT PLAN**

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan of Versiti 403(b) Retirement Plan and Employer Identification Number 45-4675354/Plan Number 003 for the plan year January 1, 2024, through December 31, 2024. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$9,270,684. These expenses included \$87,330 in administrative expenses and \$9,161,271 in benefits paid to participants and beneficiaries, \$22,083 in certain deemed and/or corrective distributions. A total of 623 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$95,490,200 as of the end of the plan year, compared to \$92,932,864 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$2,557,336. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$11,828,020, and earnings from investments of \$11,828,020.
